## Executive Summary

This report marks the Phase 1 Closure Report in the Monitoring and Evaluation process of the NSDMA School Safety Policy Compliance Course. It provides details on the progress in registrations, certification, and the overall trajectory of the 'Digitising the School Safety Policy' Project through June 2024.

We are proud to present in the Closing Report that the SSP Course has reached a total **5941 registrations** across Nagaland with a total of **2069 teachers certified** in the course as of June 2024.

Key accomplishments include the achievement of Phase 1 targets, a significant increase in registrations, and continued promotional campaigns. These developments are the result of the collaborative efforts of the NSDMA, DoSE, and NagaEd.

During Phase 1, various **social media campaigns** were also undertaken which garnered **over 16 lakh ad views by more than 3 lakh people**, significantly boosting SSP course registrations in May and June.

The SSP course continues to have an active online presence and is observing registration by teachers across different schools in Nagaland. The Course is also receiving a lot of **positive feedback** from teachers who have completed the course.

In order to create visibility and better motivation for teachers to register for the course, herein this report, are attached the total number of registrations to date, names of all teachers who have registered for the course per district, list of teachers certified in the course, details of performances district-wise, and impact of social media campaigns. This, in turn, can be disseminated among the EBRCs and other stakeholders to take action in districts that have low rates of registration and completion.

## Key Accomplishments in June (Phase 1 Closure)

5941 Registrations

2069 Certifications

### Phase 1 Target Achieved:

The closing month of Phase 1 observed a 167% increase in registrations in June. The initial target of 3000 teacher registrations was surpassed, achieving **5941 registrations**. (Please refer to *Annexures 1 and 4* for the detailed list of teacher registrations by district).

### Course Completion and Certification:

To date, **2069** teachers have been **certified** in the SSP Compliance Course, with NagaEd sending digital certificates on a monthly basis. (Please refer to *Annexure 5* for the detailed list of certified teachers).

### High Impact of Social Media Campaigns:

The various efforts of all departments in promoting the SSP course via various social media campaigns and print media has received good traction and high impact. The social media initiatives for the project have generated significant buzz and impact, where the ads were seen **over sixteen lakh seventy six times** by over **three lakhs sixty four thousand people**.

### Phase 1 In-person Closing Meeting with NSDMA, DoSE, and NagaEd on 21st June 2024:

Representatives from all three departments discussed project progress, achievements, and future steps and discussed the prospects of Phase 2 of the project.

### Continuous Support from NagaEd:

Ongoing support for EBRCs and teachers facing registration challenges is being provided by NagaEd via different channels.

## Community Engagement and Outreach:

Through the combined efforts of all departments in promoting the SSP course via various social media campaigns and print media, the project has generated significant buzz and impact. Throughout Phase 1, several social media campaigns were initiated on various digital platforms, where the ads were seen **over sixteen lakh seventy six times by over three lakhs sixty four thousand people**.

- **Overall Impressions:** 16,76,098 (the number of times the content was seen, including multiple views from individual users).
- **Total Reach:** 364,048 (the number of users who saw the SSP post in their news feed).

These impressive figures highlight the positive impact and reception of the SSP course promotional materials, leading to a substantial increase in registration numbers in May and June.

## Current Status:

Since the last report in May 2024, the SSP course has seen a **167%** increase in registrations, jumping from **2,225 to 5941** registrations by the close of Phase 1 in June.

In light of the completion of Phase 1 of the SSP roll-out, **it is advised that all departments start preparations for the second phase wherein protocols and directives to achieve the next target** should be envisioned.

In order to boost further registrations and also to increase course completion rates by teachers, it is advised that the DoSE, NSDMA, NagaEd focus on methodologies to achieve these in Phase 2.

Efforts to continue with the promotional campaigns will also be continued to be undertaken by NagaEd and the NSDMA.

The SSP Course also **continues to observe an increasing trend in registrations even after the completion of the first phase** which forecasts a positive outlook for the project.

Additionally, the team at NagaEd is actively monitoring the registrations and completion progress of teachers in the Compliance Course monthly.



## Recommendations and Action Items:

With Phase 1 completed and targets achieved, the NSDMA, DoSE, and NagaEd held a joint in-person meeting on 21st June 2024 at the NSDMA Office, Secretariat. The following recommendations and action items were discussed during the meeting:

### ● Initiation of Phase 2 Roll-out:

Directives on this are yet to be received from NSDMA. Focus Areas: Increase in course completion and certification, boost registrations from all districts, particularly the bottom-performing blocks.

### ● Effective Promotional Channels:

The following promotional channels were observed to be effective in campaigning for the SSP Course in Phase 1. It is also advised that such channels continue to be utilised for effective promotion of the SSP project.

- Social Media (NagaEd)
- Department Notifications by DoSE
- Social Media Ads by NagaEd, NSDMA, and DoSE
- Newspaper Ads by NSDMA
- Use of Influencers on Social Media
- Newspaper Promotion Ads by NagaEd, DoSE, and NSDMA

### ● Empowerment Initiatives:

- More Effective Mobilisation of EBRCs to cover government schools.
- More Effective Mobilisation of ANPSA to cover private schools.

### ● Official Communications:

Along with Notification Circulars sent by DoSE, DEOs at the District Level should be leveraged to send notifications to schools/teachers for better communication and effective action.

### ● Recognition and Awards:

- Award Ceremonies and Plaques/Certificates for top performing schools.
- Leverage Teachers' Day for Awards and for further promotion and showcase of the SSP Compliance Course.

### ● Promotional Activities:

- Short Videos of Teachers discussing SSP's impact to be utilised in Social Media as Promotional Stories.
- WhatsApp notifications for reminders regarding registration, course progress, and completion.
- SSP Demo-cum-Mock Drill Skit on Teachers' Day to be considered for further outreach and promotion.
- Opportunities for News Items to be explored such as Visitation of School by DoSE's PD, Publication of Target Achievements of First Phase in Newspapers, etc.
- Utilise Influencers and Social Media: Generate interest and outreach through influencers and social media apps

The active online presence and collaborative efforts have facilitated registrations across various schools in Nagaland. With a steady increase in registrations and completions, the project demonstrates a positive outlook. 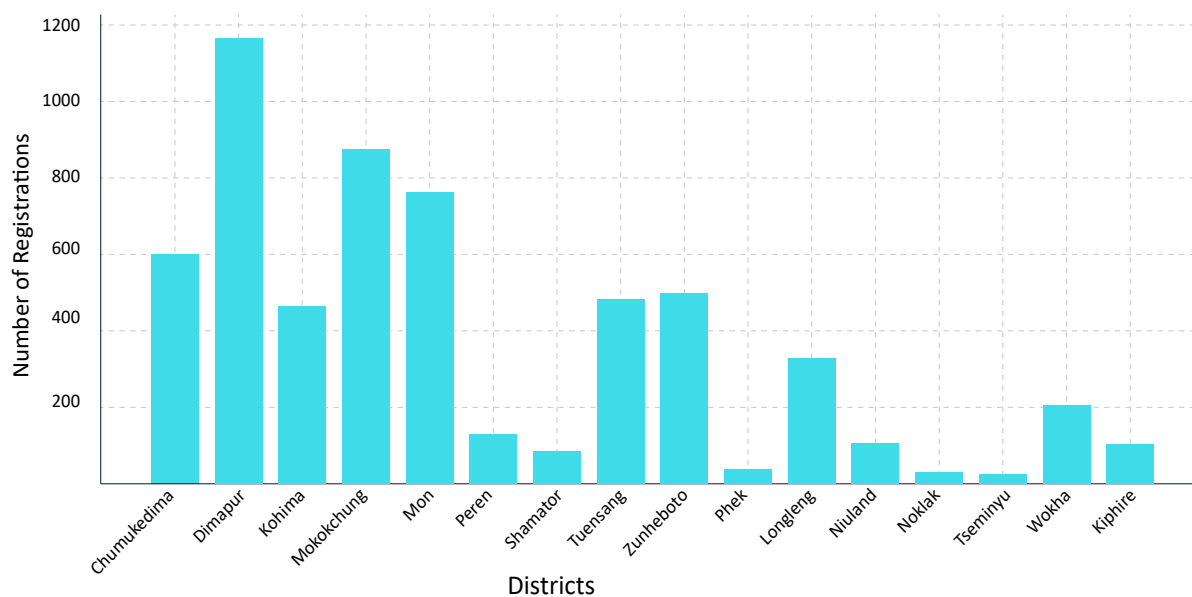

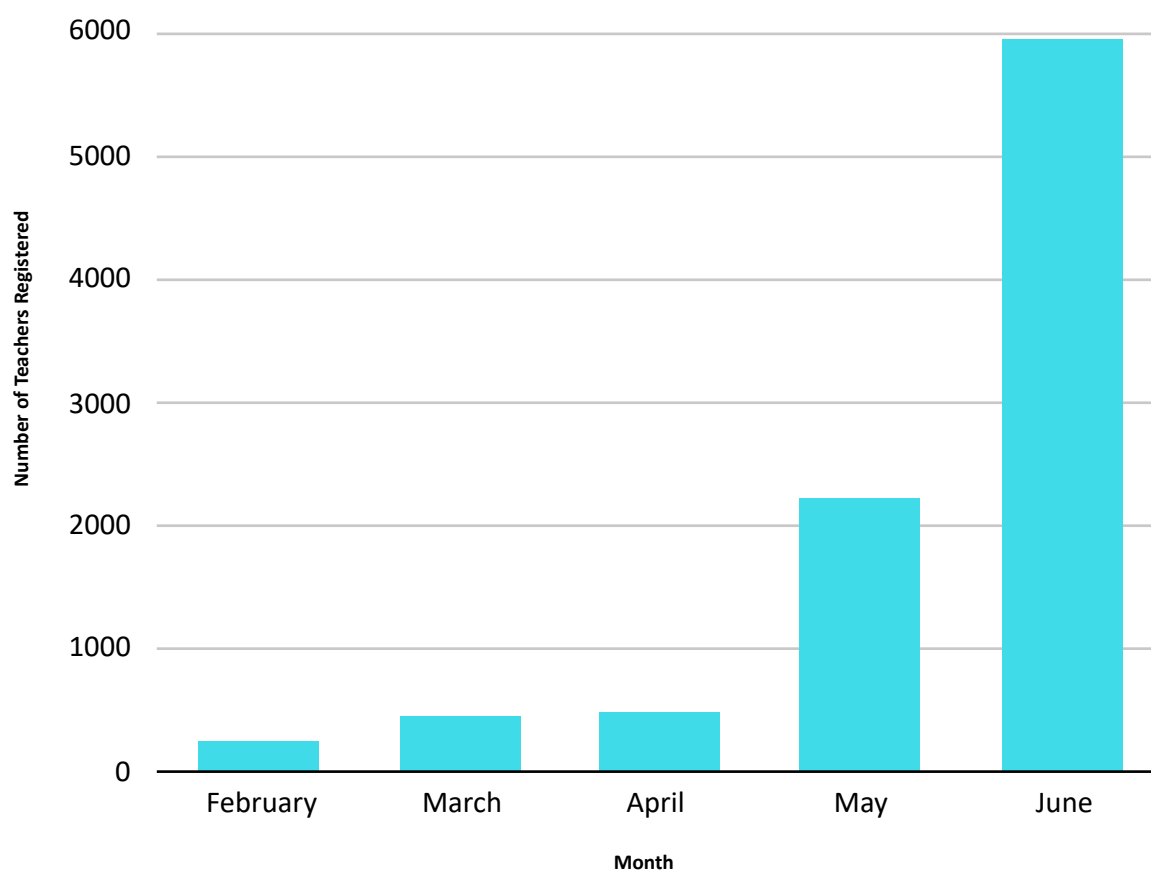
NSDMA SSP Teacher Registrations by District

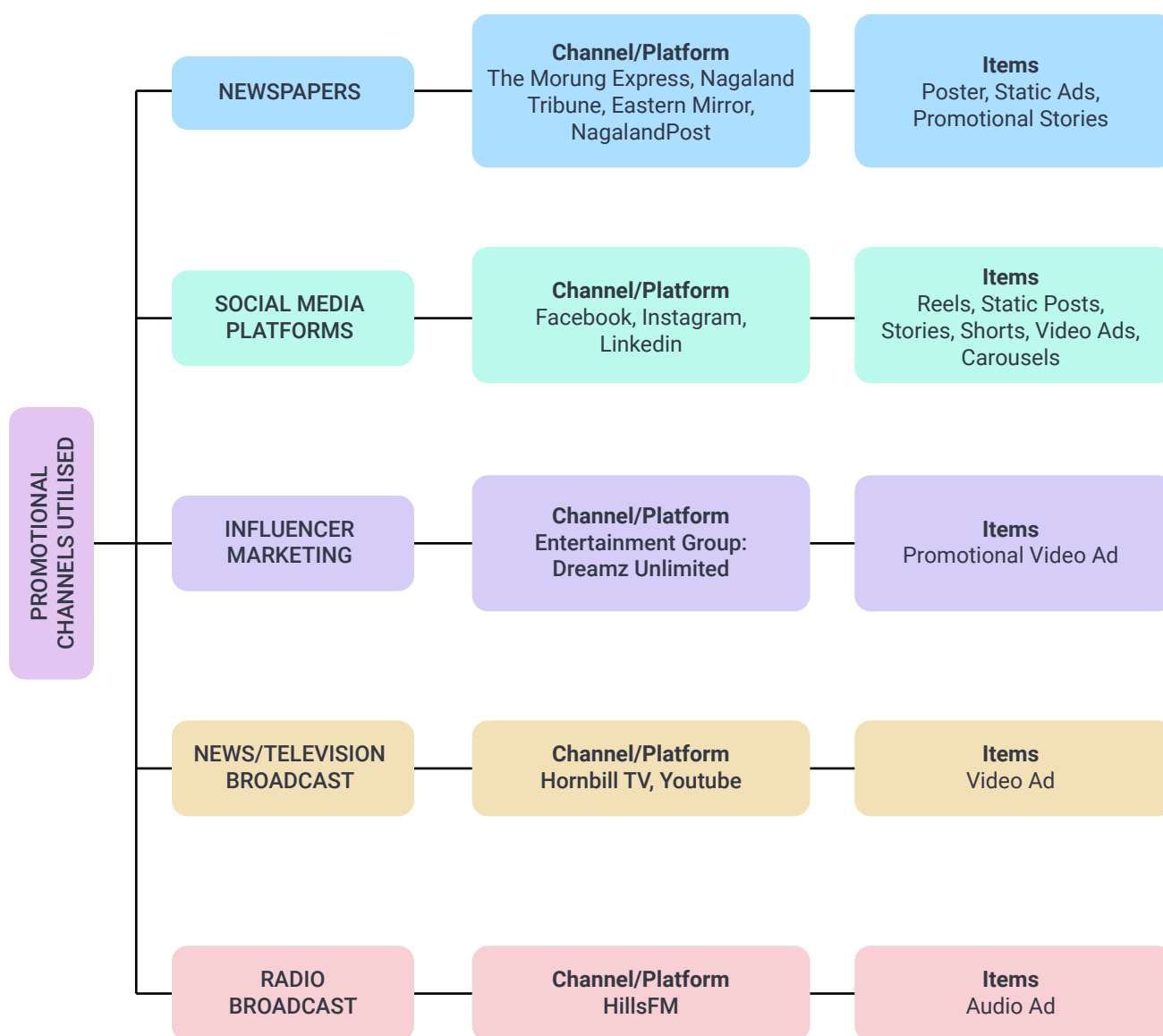

### Importance and Relevance of the Course

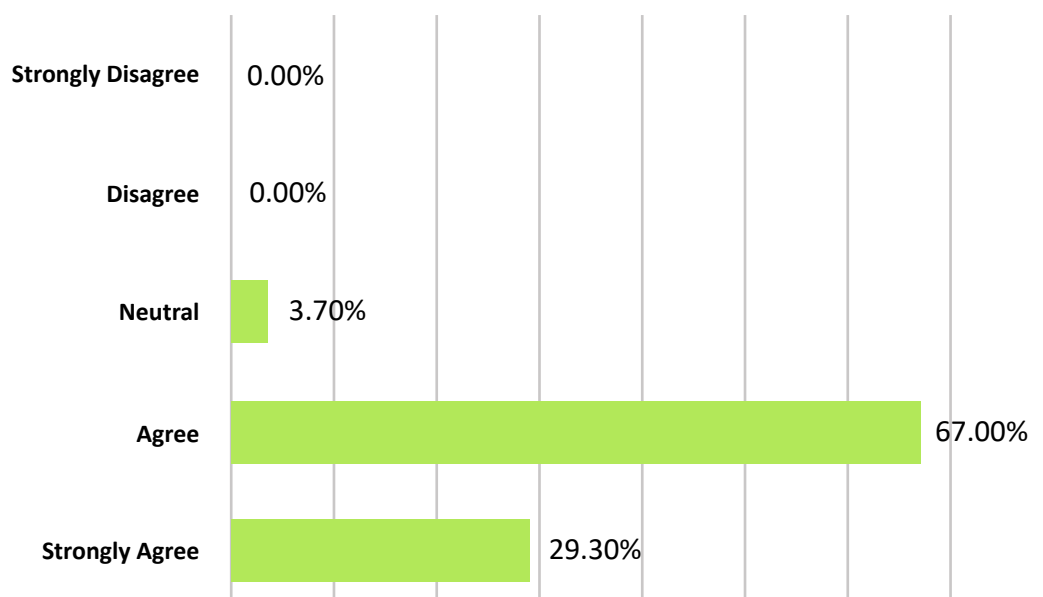
#### The School Safety Policy Compliance Course is a much needed programme in the State.

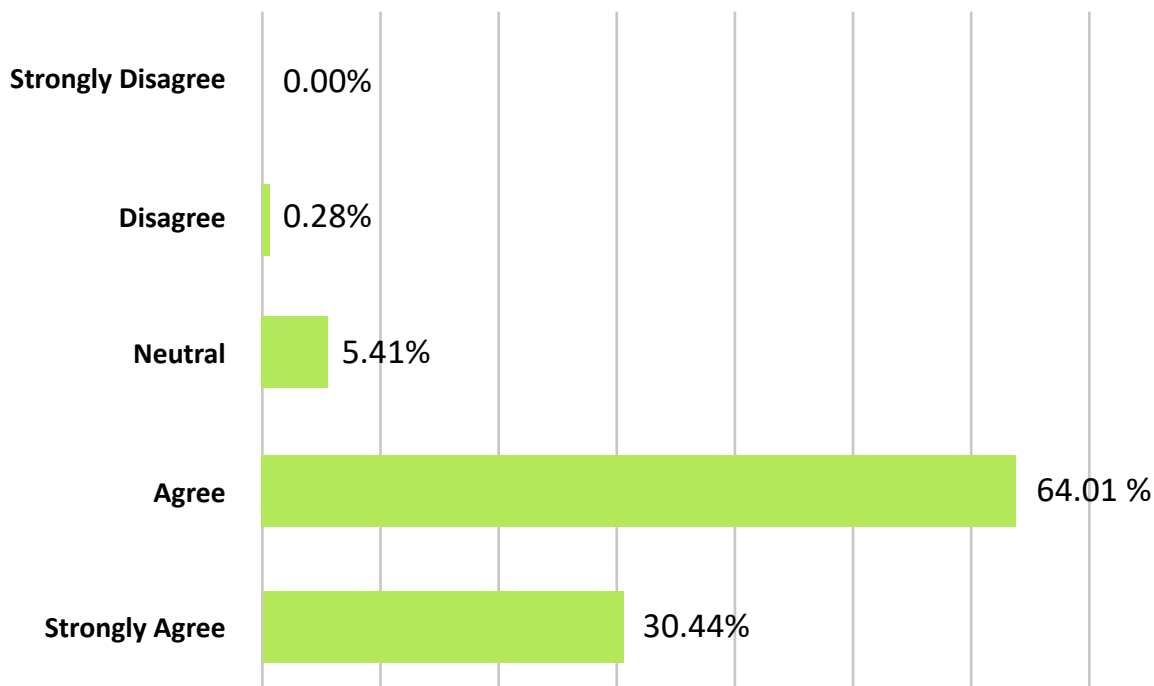
#### The Objectives of the Course were Clearly Defined.

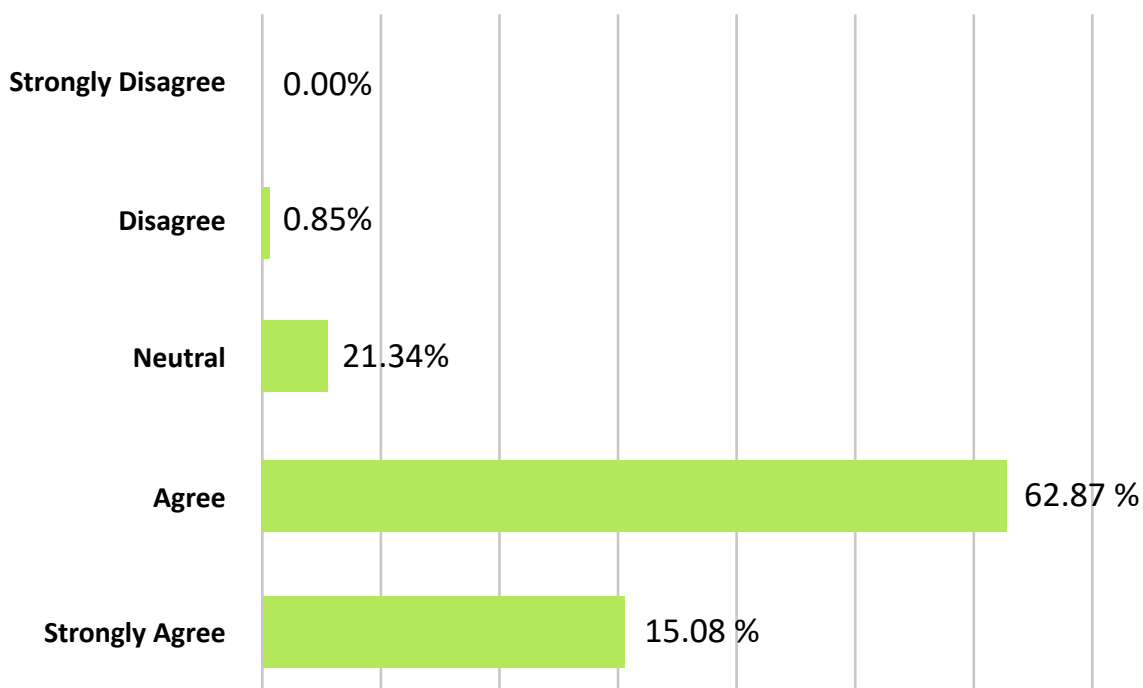
### The Topics Covered in the School Safety Policy Compliance Course were Relevant.

### The School Safety Policy Compliance Course is Relevant to the Teachers' Area of Work.

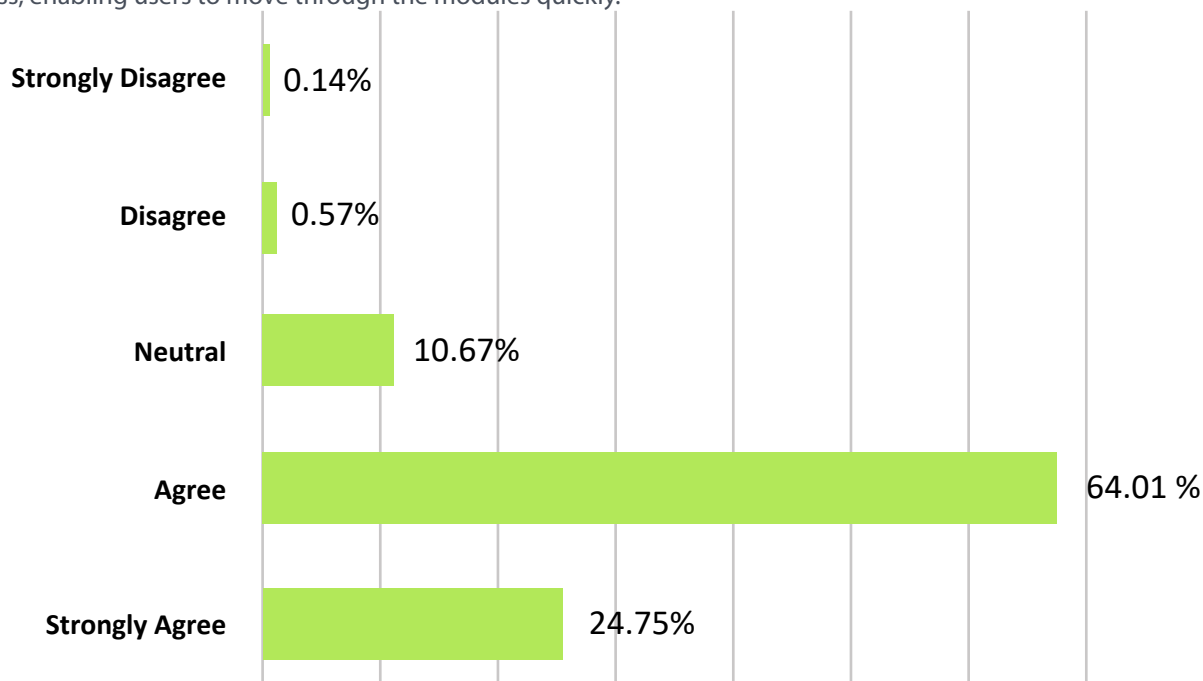

## Easy Access and Navigation of the Course

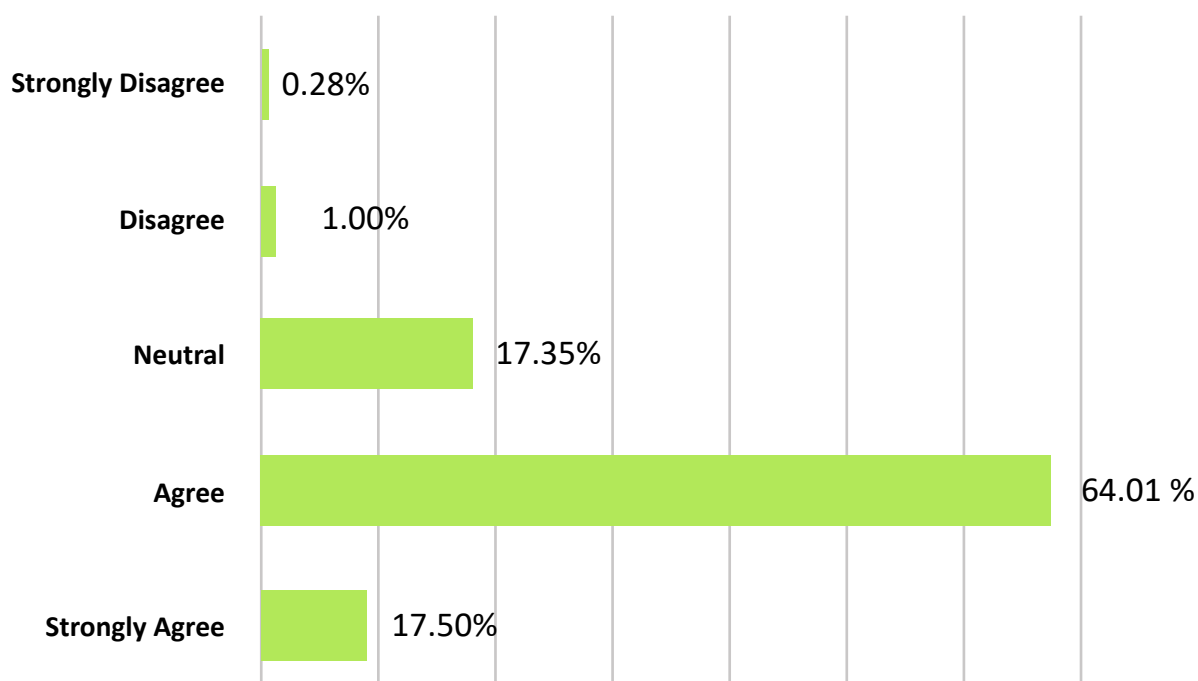
### The Contents of the Compliance Course were Well-organised and Navigation of the Course was Easy to Follow.

### The School Safety Policy Compliance Course is Easier to Navigate in its Digital Format than the Book Version.

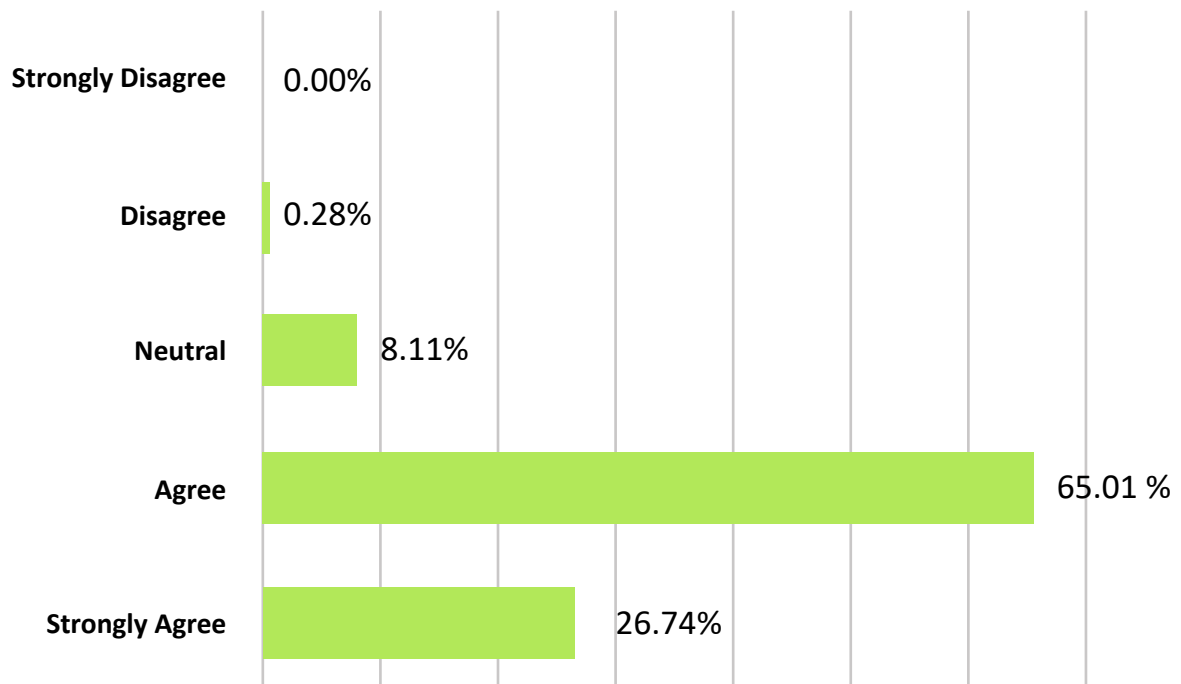

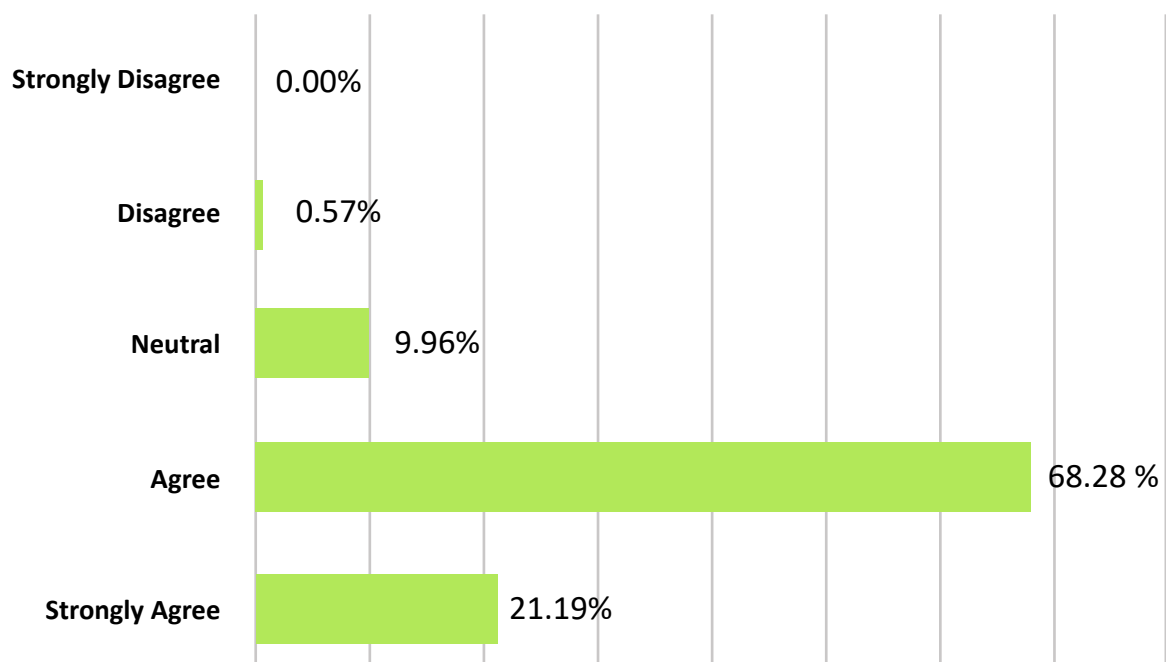
### The Video Content in the Compliance Course is Engaging and Easy to Understand.

### The Interactivities (Slides, Flashcards, Games, etc) in the Compliance Course are Easy and Fun to Use.

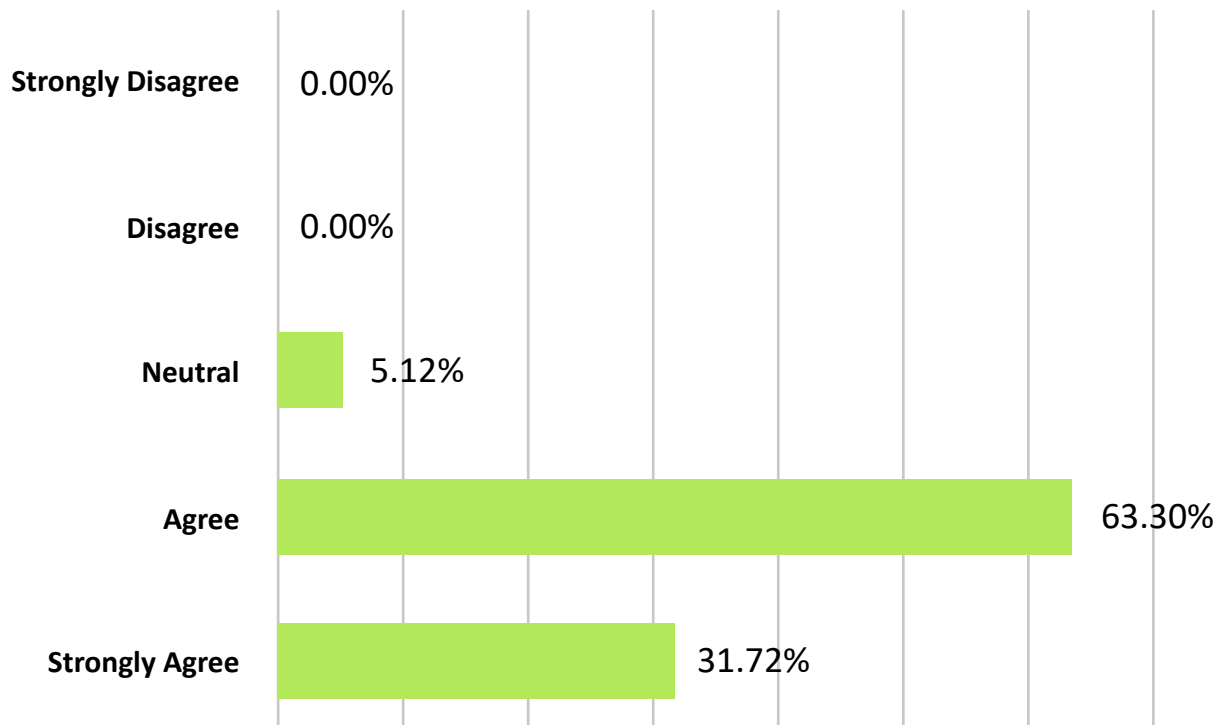

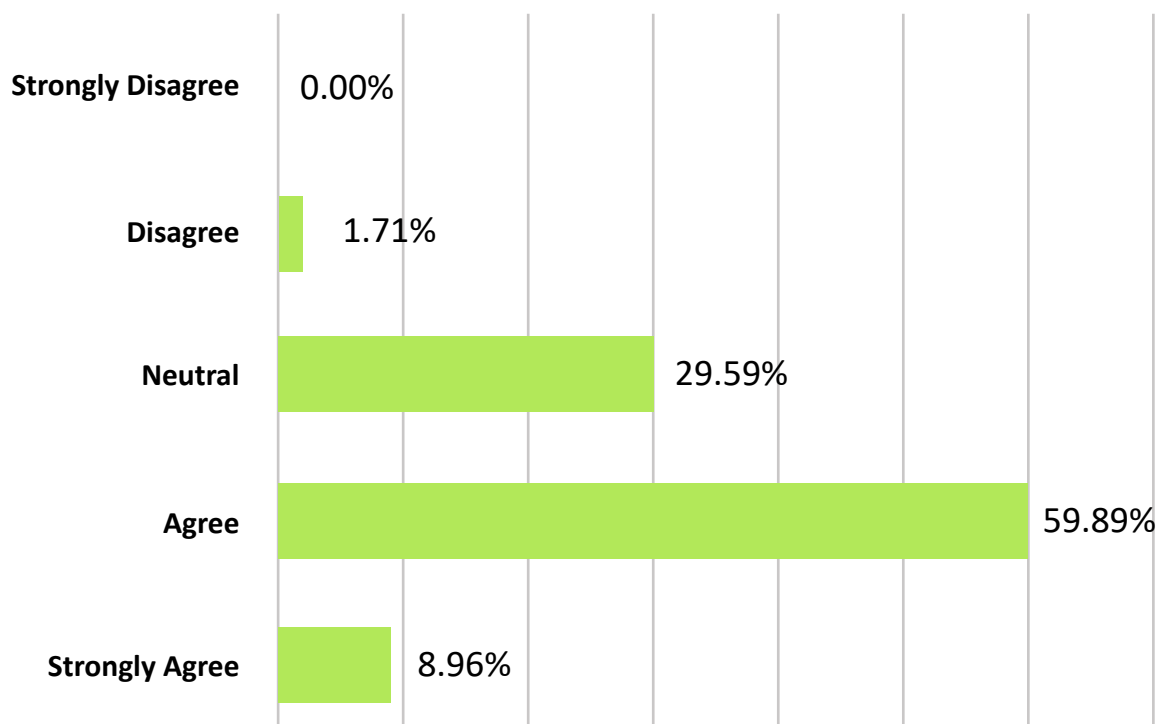
## The 'Check your Understanding' Quizzes were important to the Course and Easy to Attempt.

### Importance of the module



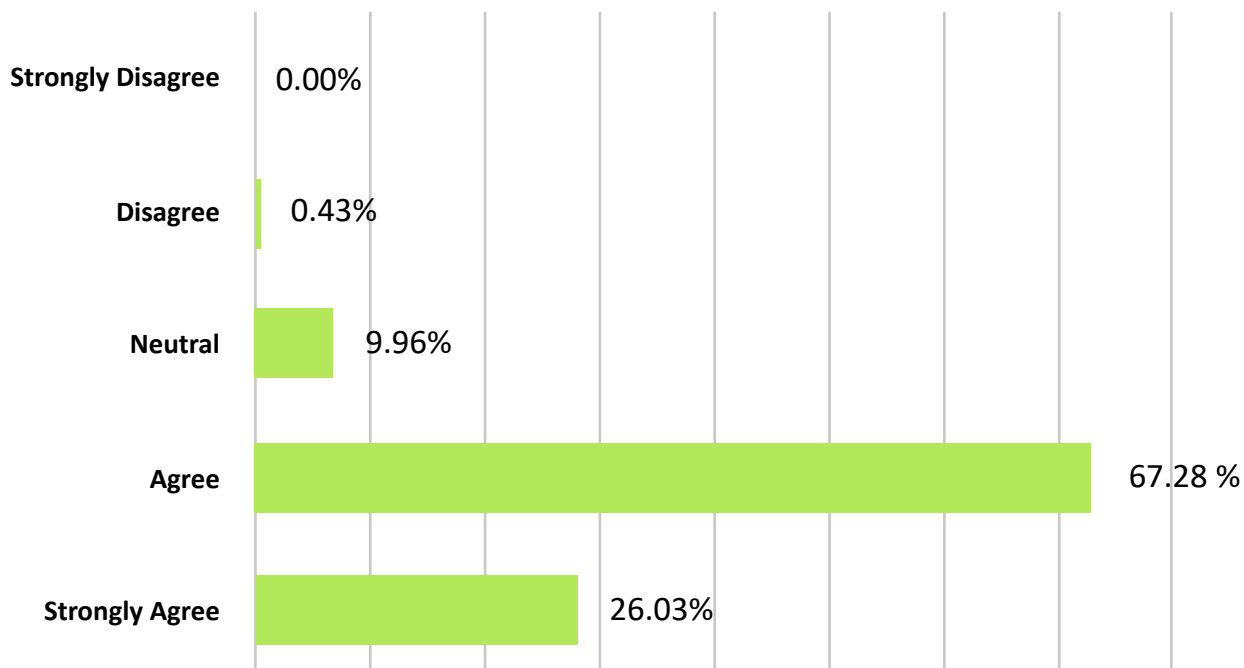
### Module Quiz Attempt



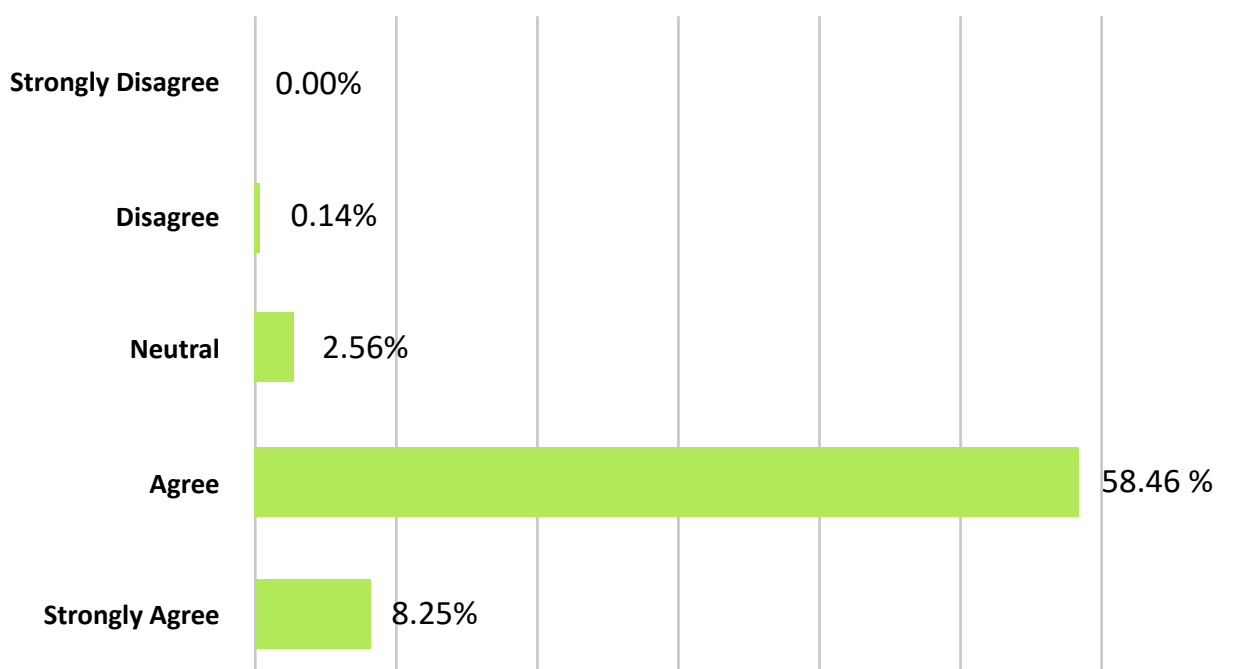
## The 'Apply your Learning' Quizzes were important to the Course and Easy to Attempt.

### Module Importance



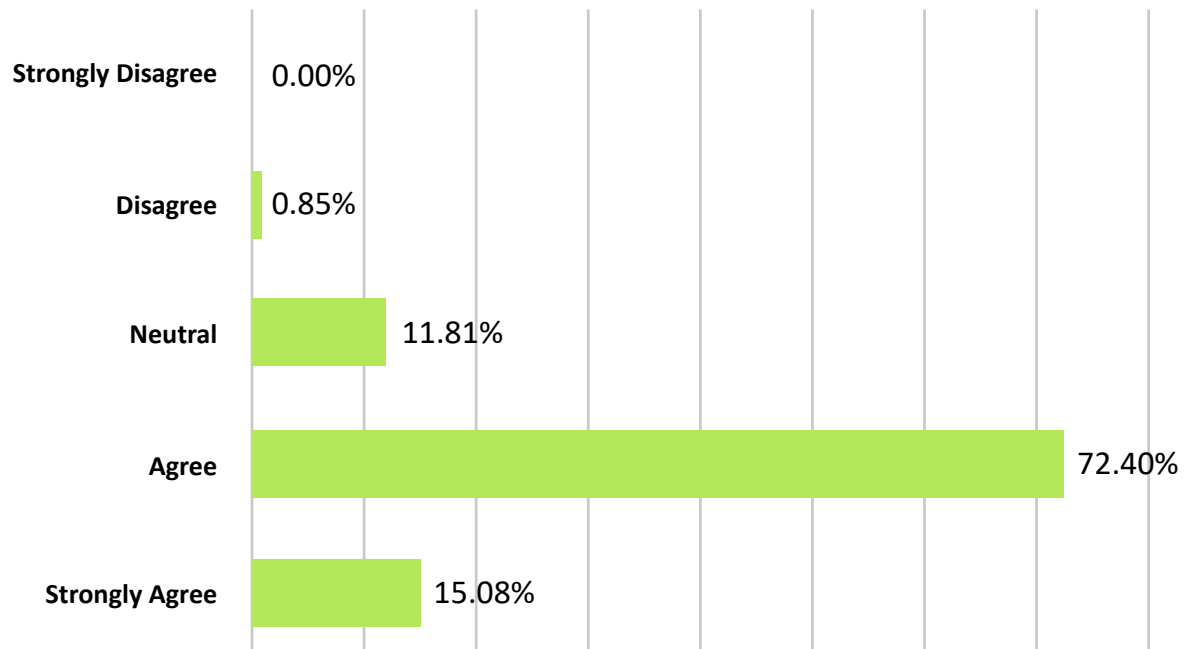
### Module Quiz Attempt



## Reception and Acceptance of the Course

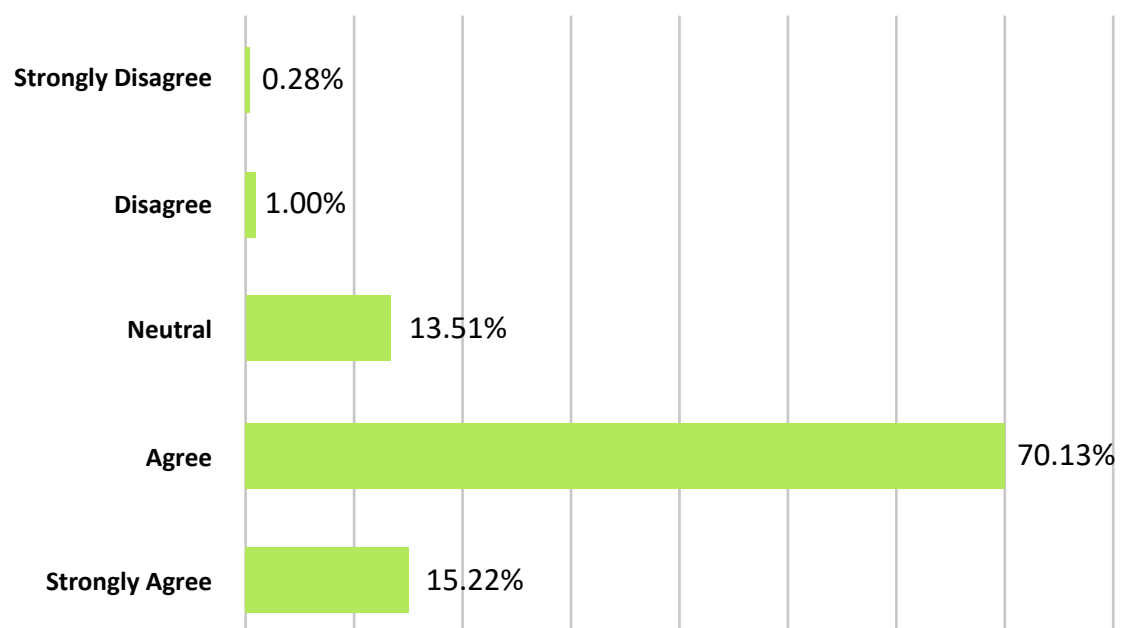
**Teachers were receptive to change (to a different mode of learning and training) and prepared to complete the Compliance Course.**

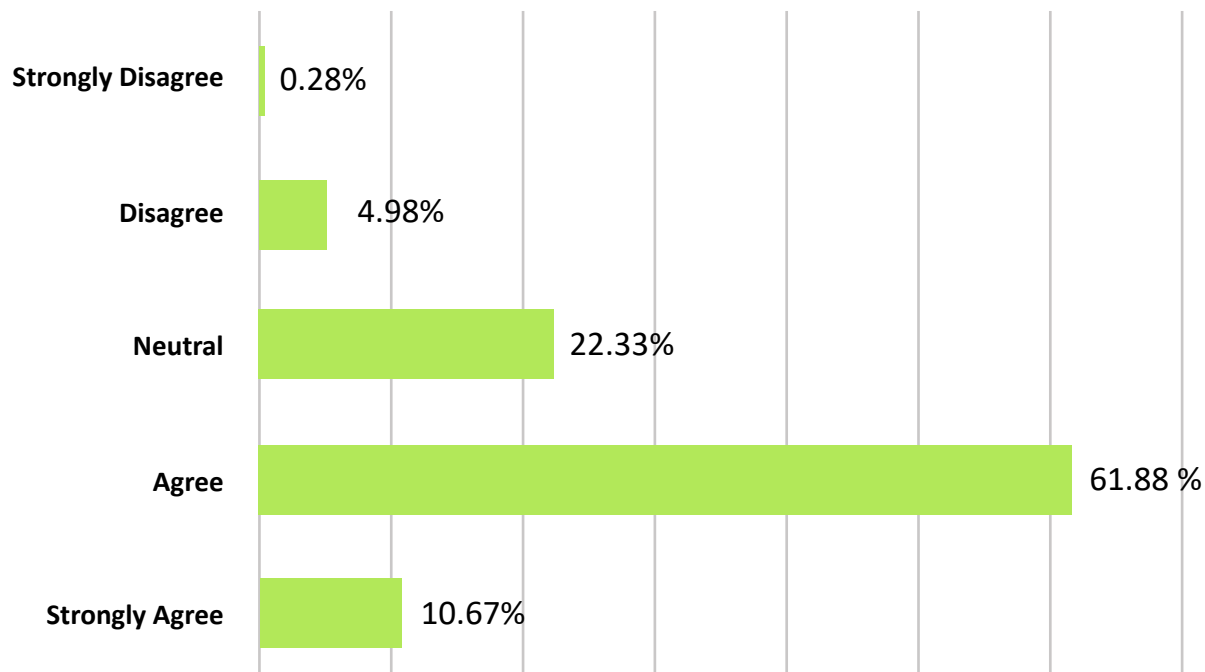
**Users were provided with sufficient resources and expectations for the Compliance Course.**

## Benefits received from the Training and the Compliance Course: Responses from Users

- **Better Personal Preparedness:** Building capacity to mentor others, with an emphasis on risk mitigation and raised safety standards, are examples of both personal and community improvement.
- **Proficiency in Disaster Management:** Acquired a profound comprehension of disaster management, including various crisis situations and conducting search and rescue missions.
- **Comprehensive Application:** Gained a thorough grasp of safety protocols, disaster management policies, and stakeholder roles, enhancing the implementation of these ideas in practical settings.

## Recommendations to Enhance Experience in the Future: Responses from Users

On being asked if the users had any recommendations to enhance their experience with future training and compliance programmes, the users had the following inputs:

- **More Mock Drills and Practical Training:** Conduct frequent, practical training sessions and hands-on mock drills to improve the application of skills in real-world scenarios. This includes having experts give real-world examples and holding simulated drills in classrooms.
- **Improved Material Format and Accessibility:** Make course content available in both physical and digital media, offer handbooks that can be downloaded, and create shorter videos to increase the accessibility of training materials. Make sure that every video and resource can be seen and accessed with ease.
- **More Engaging and Interactive Content:** Use interactive components like case studies, simulations, and real-world scenarios. To improve the effectiveness and engagement of the learning process, include quizzes, shorter films, and visual aids.
- **Timely and frequent training and updates:** Arrange for yearly or quarterly courses as well as frequent training sessions and updates to ensure that participants are up to date on the most recent safety procedures and best practices. Make sure to communicate training dates and materials in a timely manner.
- **A stronger focus on school and community involvement:** Encourage community involvement and provide disaster management education to students and staff in schools. Plan awareness campaigns to train educators, students, and the community at large, among other stakeholders.

### Other Comments on Overall Experience

#### Positive Experience

- **Interesting and Educational:** Participants felt the course was beneficial and enhanced their understanding of disaster management.
- **Content Quality:** Valued for its helpful suggestions and informative explanations.
- **Variation:** Although some people preferred offline options due to eye strain, the digital version was well-received.
- **Curriculum Integration:** Provide regular training and include disaster management into school curricula.

#### Recommendations for Improvement:

- **Learning Time:** More time needed to complete the course
- **Format and Aids:** To improve comprehension, include handbooks and visual aids.
- **Mock Drills:** Expand their frequency and variety, particularly in targeted areas.
- **Technical Problems:** Take care of issues using digital tools and think about doing in-person demos.
- **Safety Measures:** Increase the frequency of training and raise the bar for school safety.
